1. Introduction

The Telecommunications Authority of Trinidad and Tobago (“the Authority”), in the fulfilment of its mandate under the Telecommunications Act Chap. 47:31 (“the Act”) is committed to making evidenced based decisions using only relevant and accurate information in the execution of its regulatory functions. Towards this end, the Authority has recognised that there is a need for the issuance of Regulations which will require the submission of certain specific and prescribed information by authorised providers and licensees to the Authority to be accurate, reliable and timely.

1.1 Relevant Legislation

In order to support the Authority’s achievement of its regulatory functions and mandate as set out in Sections 18 (1) (a)-(r) of the Act, section 22(3)(c) of the Act envisages that all authorised providers be obliged to provide information and reports to the Authority:

“Every concession for a public telecommunications network, a public telecommunications service or a broadcasting service shall contain conditions regarding— ...

(c) the provision of information and reports to the Authority;”

Further, all authorised providers are obligated under Condition A28, ‘Requirement to Furnish Information to the Authority’ of their respective concession to:

“... furnish to the Authority, in such manner and at such times as the Authority may reasonably direct, either in writing or by a general notice published by the Authority, such information related to the activities of the authorised provider under this Concession, including but not limited to network or service development plans, financial, technical and statistical information, accounts, service performance metrics and other records, as the Authority may reasonably require in order to perform its functions.”

1.2 Review Cycle

When need for modification is identified, in order to adapt to the needs of the telecommunications and broadcasting industry and to meet changing circumstances, the Authority will announce its intention to review the document

and any interested party or entity in the telecommunications sector or any appropriate industry forum may suggest changes to the document.

1.3 The Consultation Process

The Authority sought the views and opinions of the general public and other stakeholders regarding the proposals made in this document, in accordance with the Authority's *Procedures for Consultations in the Telecommunications Sector of Trinidad and Tobago* which can be found on the Authority's website at <https://tatt.org.tt/Portals/0/Documents/Procedures%20for%20Consultation%20in%20the%20Telecommunication%20and%20Broadcasting%20Sectors.pdf>.

Following consultation and amendments (where appropriate) these Proposals for a Draft Telecommunications (Submission of Information) Regulations, will now be submitted to the Minister for approval and promulgation by negative resolution of Parliament in accordance with section 78 of the Act.

1.4 Other Relevant Documentation

These Regulations necessarily touch and concern ALL frameworks, policies and Regulations, which may be referenced on the Authority's web page at: www.tatt.org.tt.

2. Rationale

The Proposed Draft Telecommunications (Submission of Information) Regulations focuses on the method, manner and content of information submissions and in so doing seeks to:

- Formalise and streamline the data collection process between the Authority and authorised providers and licensees
- Encourage effective, efficient and accurate data collection
- Reduce the reporting burden of authorised providers and licensees
- Enhance the reporting relationship between the Authority and authorised providers and licensees

- Ensure confidentiality and appropriate use of sensitive data/ information; and
- Promote a culture within the Telecommunications and Broadcasting sectors whereby information is managed as a valuable tool in developing the sectors.

An overview of the draft Regulations is provided below, followed by the proposed draft Regulations for consideration of interested parties.

2.1 Overview of the Proposed Regulations

SHORT TITLE

Regulation 1 provides for the short title of the proposed Regulations.

DEFINITIONS

Regulation 2 sets out the interpretation of terms used in the proposed Regulations

SUBMISSION OF INFORMATION BY AUTHORISED PROVIDERS

Regulation 3 addresses the authorised providers' obligation to submit certain prescribed information to the Authority as referenced in the First Schedule.

SUBMISSION OF INFORMATION BY LICENSEES

Regulation 4 sets out the licensees' obligation to submit certain prescribed information to the Authority as referenced in the Second Schedule.

COMMENCEMENT OF SUBMISSION OF INFORMATION

Regulation 5 deals with the timeframes for commencement of submission of information for authorised providers.

UNSCHEDULED REQUESTS FOR INFORMATION

Regulation 6 enables the Authority to request information which may not be listed in the Schedules and/ or outside of the scheduled timelines for submission, stipulating that the authorised provider/ licensee receive no less than fourteen (14) days' notice of such request.

MANNER OF SUBMISSION

Regulation 7 enables the Authority to prescribe the manner of the submission of required information.

CERTIFICATION OF INFORMATION

Regulation 8 requires that all submissions set out in the First and Second Schedules be accompanied by a signed Certificate, in the form provided in the Third Schedule.

REQUIREMENT TO MAKE STATUTORY DECLARATION

Regulation 9 requires that where a request for submission of information is made by the Authority, and the Authority has any doubt regarding its validity or accuracy, that the authorised provider/ licensee make a Statutory Declaration with regards same.

VERIFICATION OF INFORMATION SUBMITTED

Regulation 10 enables the Authority to request original copies of documentation submitted for the purpose of verification.

AMENDMENT

Regulation 11 empowers the Minister to make changes to the Schedules by Order.

USE OF THE INFORMATION BY THE AUTHORITY

Regulation 12 enables the Authority to use the information submitted for the purpose(s) outlined in the Schedules as well as for any other purpose(s), given prior notification and reasoning.

OBJECTION TO USE OF INFORMATION

Regulation 13 provides for the authorised provider/ licensee to object to the use of its submitted information for any purpose other than that which is identified in the Schedules.

CONFIDENTIALITY

Regulation 14 addresses the treatment and use of confidential information by the Authority.

PROCEDURE FOR DISCLOSURE OF CONFIDENTIAL INFORMATION

Regulation 15 provides an opportunity for the authorised provider/ licensee to make representations regarding the disclosure of its confidential information

which is deemed by the Authority to be necessary to disclose in the discharge of its functions.

WITHOUT PREJUDICE

Regulation 16 provides that submission of information pursuant to these Regulations are without prejudice clause to any other requirement to submit information to the Authority contained in the Act, any concession, licence, or other Regulations made under the Act.

OFFENCES

Regulation 17 reiterates the offence under Section 71 of the Act for the failure to submit required information, submission of false or misleading information, failure to comply with any provision of these Regulations.

It is to be noted that the suggested Regulations that are attached at Section 3 are illustrative only of the policy positions outlined above and should not be construed as ACTUAL drafting amendments. Amended legislation shall be prepared by the requisite legislative drafters.

| Citation | 1. These Regulations may be cited as the Telecommunications (Submission of Information) Regulations, 201 7 ⁶ , hereinafter referred to as the “Regulations” . |
| Interpretation | 2. (1) Unless otherwise defined herein, terms used in these Regulations shall have the meanings given in the Act.

(2) In these Regulations:

“Authority” means the Telecommunications Authority of Trinidad and Tobago

“Act” means the Telecommunications Act, Chap. 47:31;

“authorised provider” means a person authorised pursuant to section 21 of the Act to operate public telecommunications networks or to provide public telecommunications or broadcasting services and may refer to all providers collectively or individually, as the context requires; |

“central office code” means a three-digit number, ranging from 100 to 999, which represents a group of up to 10,000 telephone numbers allocated by the Authority to an authorised provider pursuant to section 44 of the Act;

“information” includes but is not limited to data, codes, computer programmes, software and databases;

“licensee” means the holder of a licence granted by the Authority pursuant to section 36 of the Act;

“submission date” means the date, as specified in the relevant Schedule, on which particular information is required to be submitted in accordance with these Regulations;

“subscriber” means a customer that pays an authorised provider for a subscription to telecommunications and/or subscription broadcasting services for personal or business purposes;

“subscription” includes post-paid and active prepaid subscriptions;

“tariff” includes the price as well as all other terms and conditions under which a telecommunications or broadcasting service is provided; and

“website” where applied to the Authority means the collection of web pages accessible via the Internet at the web address printed on the Authority’s letterhead.

Submission of
information by
authorised
providers

3. Every authorised provider shall, on or before the relevant submission date in each year during the term of its concession, submit to the Authority the information and data set out in the First Schedule in respect of all networks operated or services provided by the authorised provider pursuant to its concession.

Submission of information by licensees

4. Every licensee shall, on or before the relevant submission date in each year during the term of its licence(s), submit to the Authority the information and data set out in the Second Schedule in respect of all radio-transmitting equipment owned, installed, operated or maintained by the licensee or any radio communications services operated by the licensee.

Commencement of submission of information

5. (1) Authorised providers shall commence the submission of information required in Part A of the First Schedule, at the end of the second quarter following commencement of authorised service or as may be otherwise directed by the Authority.

(2) Submissions required under Part B of the First Schedule shall be made on the February 28th immediately following commencement of authorised service unless such date falls within six (6) months of such commencement, in which case submissions so required shall be made on the next February 28th following or as may be otherwise directed by the Authority.

Unscheduled Requests for Information

6. (1) The Authority may, from time to time, upon the commencement of an investigation or in fulfillment of its functions and obligations under the Act, require the authorised provider or licensee to submit information which may not be listed in the Schedules to this Regulation or which may be outside of the prescribed timeline for submission.

(2) Where a request under sub-regulation (1) is made, the Authority shall do so in writing giving the authorised provider no less than fourteen (14) days to submit the requested information.

Manner of submission

7. Information to be submitted to the Authority pursuant to these Regulations shall be submitted in writing addressed to the Chief Executive Officer and in the

manner required by the Authority.

Certification of Information

8. (1) Information submitted to the Authority under these Regulations shall be accompanied by a statement certifying that the information is true, accurate and complete.

(2) The statement shall be in the form set out in the Third Schedule, and shall be signed by a duly authorised representative of the authorised provider or licensee on whose behalf the information is being submitted.

Requirement to make Statutory Declaration

9. (1) Where information is requested and subsequently submitted to the Authority under these Regulations and the Authority has doubt as to its validity or accuracy, the Authority, in addition to any other available remedy under these Regulations, shall require the respective authorised provider or licensee who submitted the information to make a Statutory Declaration attesting to the truth of the information, prior to use by the Authority in any investigation of non-compliance or decision making process.

(2) The Statutory Declaration referred to in subregulation (1) shall be made and provided to the Authority within fourteen (14) days of the Authority's written request for same.

Verification of information submitted

10. The Authority shall, upon the giving of seven (7) days' notice, have the right to mandate that an authorised provider or licensee submit to the Authority for its inspection, any relevant original records, for the purpose of the verification of any information submitted to the Authority pursuant to these Regulations.

Amendment by the Authority of the Schedules.

11. The Minister may, upon the advice and recommendation of the Authority, amend the Schedules to these Regulations by Order.

- Use of information by the Authority
12. (1)The Authority may request and subsequently use the information submitted for any and all of the corresponding purpose(s) specified in the relevant Schedule(s).
- (2)Where the Authority requires use of the submitted information for any purpose not stated in the relevant Schedule but related to the Authority’s functions under the Act, the Authority shall give the authorised provider or licensee no less than fourteen (14) days’ notice of the purpose for which the Authority proposes to use the information.
- Objection to use of Information
13. A person receiving a notice under Regulation 11(2), may object in writing to the use by the Authority of the information for a purpose other than those set out in the Schedules, and the Authority shall refrain from such use where it is shown to its satisfaction that the information is unsuitable for that purpose.
- Confidentiality of Information
14. Where the relevant Schedule provides that the Authority shall keep confidential the information submitted, the Authority shall disseminate the information only to its internal personnel who require the information for the performance of their functions, and shall not disclose the information to any other person unless:
- i. the Authority considers that disclosure is necessary in the discharge of the Authority’s functions;
 - ii. disclosure is made in connection with the enforcement of any provision of the Act, any regulations made under the Act, or any concession or licence;
 - iii. the information is or becomes public knowledge other than through disclosure by the Authority;
 - iv. the information was known to the Authority

before receipt from the person submitting the information, without any obligation of confidence;

- v. the information lawfully becomes available to the Authority from a source other than the person submitting the information; or,
- vi. the person submitting the information agrees to the disclosure.

Procedure for disclosure of confidential information

15. Prior to any disclosure of information under regulation 15(i), the Authority shall afford the person submitting the information an adequate opportunity to make representations regarding the disclosure, and shall give consideration to any representations made. Without prejudice to the generality of the foregoing, the Authority shall:

- i. give no less than fourteen (14) days prior written notice of disclosure to the person whose information the Authority proposes to disclose;
- ii. give reasonable consideration to any representations made under this Regulation; and,
- iii. where appropriate, consider such reasonable proposals made by the person submitting the information to protect the confidentiality of the information, where such proposals do not prejudice the Authority's objective in seeking to disclose the information.

Without prejudice

16. (1) The requirement to submit information pursuant to these Regulations is without prejudice to any other requirement to submit information to the Authority contained in the Act, any authorisation, licence, or other regulations made under the Act, the Authority's power to obtain information reasonably required for the performance of any of its functions, or any requirement to submit information imposed by or in relation to any

decision of the Authority.

(2) Notwithstanding (1), where the requirement to submit such information has been fully met by the person in a previous submission made pursuant to the Act, other Regulation, authorisation, or licence, the person may authorise the Authority to use same for the purposes of these Regulations.

Offences

16.17. A person who fails to comply with any of the provisions of these Regulations commits an offence under section 71 of the Act and is liable to the penalties prescribed therein.

FIRST SCHEDULE

Section A – Quarterly Submission

1. The information set out in the table below must be provided for each of the following periods in each year:
 - i. 1st January to 31st March;
 - ii. 1st April to 30th June;
 - iii. 1st July to 30th September;
 - iv. 1st October to 31st December.
2. The information shall be provided within twenty-eight (28) days of the end of the period to which it relates.
3. The Authority may from time to time by the publication of a template on its website, designate the format in which the information in the table or any part of it should be provided. The authorised provider shall comply with such format in the submission of information under this Section.
4. If the Authority does not designate a format in which the information or any part of it should be provided, the authorised provider shall submit the information in a format that would allow the Authority to easily locate and extract the relevant data.

Section B – Annual Submission

1. The information set out in the table below must be provided in respect of each calendar year.
2. The information shall be provided by the 28th February next following the year to which the information relates.
3. The Authority may from time to time by the publication of a template on its website, designate the format in which the information in the table or any part of it should be provided. The authorised provider shall comply with such format in the submission of information under this Section.
4. If the Authority does not designate a format in which the information in the table or any part of it should be provided, the authorised provider shall submit the information in a format that would allow the Authority to easily locate and extract the relevant data.
