

# **Interconnection Agreement**

**Columbus Communications**

# Agreement for the Provision of the Incoming International Call Termination to PSTN Service

Between: Telecommunications Services of Trinidad and Tobago Limited, a limited liability company duly incorporated and existing under the laws of the Republic Trinidad and Tobago having its principal office situate at 1 Edward Street, Port of Spain, Trinidad ("Customer or Service Taker").

And: Columbus Communications Trinidad Limited a limited liability company duly incorporated and existing under the Laws of Trinidad and Tobago, having its principal place of business and its registered office at 29 Victoria Square, Port of Spain, Trinidad, West Indies ("CCTL or Service Supplier")

**WHEREAS** the Parties entered into an Interconnection Agreement dated June 20<sup>th</sup> 2007 (hereinafter referred to as "the Interconnection Agreement") and agreed to interconnect their respective networks in accordance with the terms and conditions of the Agreement.

**WHEREAS** the Parties are desirous of excluding the provision of Incoming International Call Termination to PLMN and PSTN Service from the Interconnection Agreement and making provision for the same under the terms of this Agreement

## 1. DEFINITIONS AND INTERPRETATION

1.1. In this Agreement, unless the context otherwise requires:

**Call** means the set-up, holding and ending of a transmission path through the system of either Party into the system of the other Party for conveyance of messages within 3.1 KHz speech service in accordance with the relevant technical specifications, as agreed by CCTL and Customer, and reference to the conveyance of Calls by a Party means the establishment by that Party of a transmission path through that Party's system and the conveyance by that Party in accordance with this Agreement of such messages (if any) over such transmission path.

**Carrier System** means the Customer's Optical Line Termination Equipment, the matching CCTL Optical Line Termination Equipment for the relevant route, one or more 64Kbps Network Signalling Links and the point-to-point Optical Fibre between the Customer and the CCTL location.

**Country** means Trinidad and Tobago

**Designated Purpose** means the purpose referred to in paragraph 2.5 for which the Service is provided.

**The Incoming International Call Termination to PLMN Service or Service** means the service of that name more particularly described herein

**The Incoming International Call Termination to PSTN Service or Service** means the service of that name more particularly described herein.

**Point of Connection** means a physical point between the systems of CCTL and the Customer at which the provision of and responsibility for the service starts or ends.

**PLMN** means a public land mobile network in the Country

**PSTN** means a public switched telephone network or fixed domestic voice network in the Country

**Service Supplier** means CCTL

**Service Taker** means Customer

**Signaling Transfer Point** means a CCSS7 signaling facility in the CCTL or the Customer's Network.

**Subscriber** means an end-user with whom the Customer has entered into an agreement for the provision of publicly available telecommunication services.

**Subscriber Connection** means the point at which a Subscriber connects to the Service Supplier's PSTN network.

**Third Party International Telecom Provider** means a Third Party Telecoms Provider licensed to operate outside of the Country, and providing services outside of the Country, other than CCTL or the Customer.

**Third Party Telecoms Provider** means the holder of a Concession to provide telecommunications services in the Country other than CCTL or the Customer.

1.2 This Agreement and any Attachments shall be deemed to form a part of the Service Provider Agreement.

## 2. SERVICE

2.1 The Service will provide conveyance of Calls which originate on the System of a Third Party International Telecom Provider and conveyed via the Service Taker's System, from the Point of Connection defined by the Joining Service to the

applicable Service Supplier PSTN Subscriber Connections. Calls must be addressed to valid number ranges associated with the Service Supplier PSTN Subscriber Connections. The Calls will originate from Third Party International Telecom Providers in countries outside of Trinidad and Tobago selected by the Service Taker.

- 2.2 The list of countries and categories will be amended from time to time to include any additional numbers to which calls are to be conveyed pursuant to this Service, or to remove numbers.
- 2.3 CCTL will not convey Calls pursuant to this Agreement addressed to number ranges outside the country.
- 2.4 The Service is available only to holders of Concessions licensed to operate a Mobile or Fixed Telecommunications Network in the Country.
- 2.5 The service is provided in conjunction with a Carrier System.
- 2.5 The Designated Purpose is the conveyance of voice telephone calls from the Third Party International Telecom Providers terminating to Service Supplier subscriber connections in Country in the manner described in paragraph 2.1 hereof.
- 2.6 The Customer undertakes that it shall not use or cause the Service to be used other than in accordance with the Designated Purpose. Without in any way restricting breaches of this Agreement being deemed as material breaches, a breach of this clause shall be deemed to be a material breach of this Agreement.

### 3. SERVICE COMMENCEMENT AND DURATION

- 3.1 The Service Commencement Date in respect of the Service shall be the 1st April 2012.
- 3.2 The Term for this Service shall be from the date hereof to the date of expiration of the Interconnection Agreement.

### 4. CCTL's OBLIGATIONS

- 4.1 CCTL will be responsible for the metering and billing necessary to charge the Customer for all Calls passed by the Service Taker from a Third Party International Telecom Provider via the CCTL PSTN.
- 4.2 CCTL will be responsible for monitoring and managing the Service from the Point of Connection to the applicable Service Supplier PSTN Subscriber Connections.

**5. CUSTOMER OBLIGATIONS**

- 5.1 The Service Taker will be responsible for the end-to-end supervision of Calls conveyed to the Service Supplier via the Service.
- 5.2 The Service Taker will be responsible for monitoring and managing the Service from Third Party International Telecom Provider to the Point of Connection. For the avoidance of doubt, access to CCTL's and Service Taker's management systems will not be provided.
- 5.3 The Service Taker will not make any representation or warranty, or offer any indemnity to or otherwise make any commitment to Third Party International Telecom Provider on behalf of CCTL.

**6. BILLING PERIOD**

- 6.1 The Billing Period in respect of the Service shall be monthly. The Billing Period shall commence on the Service Commencement Date for that particular circuit. Billing will be in arrears for services received.
- 6.2 Billing is calculated on a per-tenth of a second basis.

**7. CONFIGURATION**

- 7.1 The Service will be provided at the CCTL location specified in Annex II hereto.

**8. CHARGES**

- 8.1 The Charges for the Service are set out in Rate Table shown as Annex I hereto.

**9. QUALITY OF SERVICE**

- 9.1 CCTL will provide the Service 24 hours a day, every day, in accordance with the quality of service principles and levels set out in the Annex III hereto.
- 9.2 Quality of Service Levels and Fault Restoration Times for the Service will be measured and reported by CCTL in accordance with the Service Quality Attachment hereto.

And: Columbus Communications Trinidad Limited a limited liability company duly incorporated and existing under the Laws of Trinidad and Tobago, having its principal place of business at 29 Victoria Square, Port of Spain, Trinidad, West Indies ("Customer or Service Taker")

The Calls will originate from Third Party International Telecom Providers in countries outside of Trinidad and Tobago selected by the Service Taker.

- 2.2 The list of countries and categories will be amended from time to time to include any additional numbers to which calls are to be conveyed pursuant to this Service, or to remove numbers.
- 2.3 TSTT will not convey Calls pursuant to this Agreement addressed to number ranges outside the country.
- 2.4 The Service is available only to holders of Concessions licensed to operate a Mobile or Fixed Telecommunications Network in the Country.
- 2.5 The service is provided in conjunction with a Carrier System.

**Amendment #4 to Interconnection Agreement between  
Telecommunications Services of Trinidad and Tobago Limited and  
Columbus Communications Trinidad Limited**

This Amendment, made and effective this 1st day of April, 2012

**BETWEEN: Telecommunications Services of Trinidad and Tobago Limited**, a company incorporated pursuant to the laws of Trinidad and Tobago and having its principal place of business at No. 1 Edward Street, Port of Spain, Trinidad, West Indies ( hereinafter called "TSTT"), **of the First Part**,

**AND: Columbus Communications Trinidad Limited** a limited liability company duly incorporated and existing under the Laws of Trinidad and Tobago, having its principal place of business and its registered office at 29 Victoria Square, Port of Spain, Trinidad, West Indies (hereinafter referred to as "FLOW") **of the Second Part**.

**WHEREAS** the Parties entered into an Interconnection Agreement dated June 20<sup>th</sup> 2007 (hereinafter referred to as "the Agreement") and agreed to interconnect their respective networks in accordance with the terms and conditions of the Agreement.

**WHEREAS** the Parties entered into an Amendment Agreement #1 effective from the 7th September 2008. Under clause 1.4 of the Amendment Agreement #1, the Tariff Schedule (Schedule 6 ) to the Agreement was amended inter alia by adding a new category of Special Access Service called National Freephone Service.

**WHEREAS** the Parties entered into an Amendment Agreement #2 effective from the 30th October 2008.

**WHEREAS** the Parties entered into an Amendment Agreement #3 effective from the 23rd April 2010. Under clause 3 of the Amendment Agreement #3, the parties amended the Tariff Schedule (Schedule 6) to the Agreement by adding transit charges to the National Freephone Service.

**WHEREAS** the Parties are desirous of amending the Agreement as well as the Amendment Agreements #1 and #3.



NOW THEREFORE in consideration of the mutual promises and covenants hereinafter set forth, TSTT and FLOW hereby agree as follows:


1. AMENDMENT


- 1.1 The Agreement as well as the Amendment Agreements #1 and #3 are amended by substituting Schedule 6 (Tariff Schedule) as amended by the Amendment Agreements with a new comprehensive Schedule 6, attached as Appendix A hereto, which will be the new Schedule 6 (Tariff Schedule) to the Agreement .
- 2. The parties further agree that Incoming International Call Termination to PLMN and PSTN Services shall not be included as part of the Agreement and as such all references to such services in the Agreement shall be disregarded.
- 3. Except as expressly amended by this Amendment, the Agreement shall remain in full force and effect.

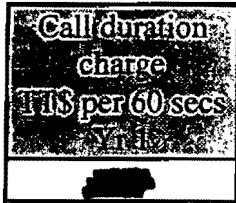

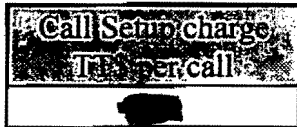

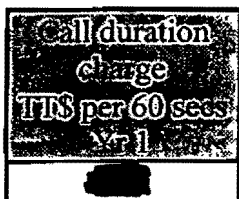
