Explanatory notes for Utilization/Forecast Reporting Form for CO Code Application Form

The Utilization /Forecasting reporting form is used for applying for initial and growth codes. The form shall be completed as follows:

- 1. The Applicant shall indicate whether the code(s) is (are) for initial or growth and whether the code(s) requested is (are) for fixed or mobile services
- 2. The name of the concessionaire and contact information of the authorized signatory
- 3. The CO code(s) that have already been assigned to the concessionaire
- 4. The switch ID if the codes are to be installed on a fixed line exchange
- 5. Current Number Assignment : The following fields shall also be completed:
 - a) Active numbers (A) These are numbers which have been assigned to customers and are making and receiving calls
 - b) Aging numbers (B) These are numbers which have been removed from service and shall be issued to new customers after a six month aging period
 - c) Reserved numbers (C) These are numbers which may have been reserved for customers and which shall be in service after the date of this application and not exceeding sixty working days
 - d) The Total quantity assigned (D) = the sum of A+B+C
 - e) Available numbers difference between the total quantity of numbers issued to the concessionaire by the Authority and the total quantity assigned (D)
- 6. Assignment history The actual assignments made on a monthly basis for the last six months preceding the date of the application for CO code(s)
- 7. Assignment forecast The actual quantity of numbers expected to be installed each month for the next twelve months. Justification shall be supplied for the forecasted numbers.
- 8. The form shall be signed and dated by an authorized person.

- 9. Formulae used in processing the CO code application
- a) % Utilisation⁵ = Quantity of Numbers assigned by authorized provider x 100

 Total Quantity of Numbers issued by the Authority
- b) Average monthly forecast = Quantity of numbers assigned over the period

 Period of time in months
- c) Months to $Exhaust^6 = \underbrace{Numbers \ available \ for \ assignment}_{Average \ monthly \ usage \ forecast}$
