CELEBRATING UNIVERSAL ACCEPTANCE (UA) DAY ON TUESDAY 18TH APRIL 2023

The Telecommunications Authority of Trinidad and Tobago (TATT) and the Latin American and Caribbean Islands At-Large Regional Organization (LACRALO) are pleased to announce the inaugural awareness seminar "Celebrating Universal Acceptance Day".

The virtual seminar will take place on Tuesday, 18th April 2023, from 9:00 A.M. to 1:00 P.M.

Universal Acceptance (UA) is an effort to ensure that all domain names and email addresses, regardless of their script, language or encoding, are treated equally and can be accessed by anyone, anywhere, on any device. The purpose of Universal Acceptance Day is to promote awareness and encourage the adoption of UA across the Internet community.

During the seminar, attendees will learn about the importance of UA and how it can benefit their organisations, businesses and communities. The seminar will feature presentations from industry leaders and experts on UA, such as Dr Ajay Data, Universal Acceptance Steering Group (UASG) Chairman and Mr Albert Daniels, Senior Manager, Stakeholder Engagement – the Caribbean, Internet Corporation for Assigned Names and Numbers (ICANN).

Other distinguished speakers from ICANN include Mr Daniel Fink, Stakeholder Engagement Director, Brazil, ICANN and Mr Mark Datysgeld, Internet Governance and Policies Consultant and Director of Governance Primer. He is also on the Generic Names Supporting Organization (GNSO) Council.

Mr Niran Beharry, Past President of the Internet Society of Trinidad and Tobago (ISOC-TT) and Mr Dev Anand Teelucksingh, Director and Secretary of Trinidad and Tobago Computer Society (TTCS), will add to the fruitful discussions of this interactive and informative seminar. Dr Claire C. Craig, Secretary of LACRALO and the Director of Research Caribbean Network Operators Group (CaribNOG) will moderate this insightful session.
